


(c) To adopt villages to provide basic amenities to the poor, such as Schools Pre primary/ Primary/Highschool/colleges, Rural Health Centres, Drinking Water for human and animals, Adult education and Non formal education for men and Women and to prepare, plan and implement area development programmes, particularly with a view to provide gainful employment to landless agricultural labours, small and marginal formers rural artisans and increase their knowledge in rural industries, irrigation, Agriculture, Sericulture, Horticulture, Afforestation, Water shed Development, Co-operation and in Agro based Vocational trainings, such as Dairy, Poultry, sheep and Goat rearing other needs for the development of such village/villages as integral and non-format means.

(d) To start, establish, run, manage and maintain all Technical Training Centres, and Diploma Technical Colleges, for imparting technical education to the poor down trodden and weaker sections of the society and also for physically handicapped persons and to establish and maintain blind school and dumb and deaf and child labour school for needy.

(e) To implement programmes for the improvement of village environment and facilities like Rural Roads, Sanitallor, low cost houses and form youth clubs, women self help groups, provides leadership and skill development training, empowerment for the purpose of undertaking development action.

(f) To give provide, render financial help and assistance to implement any schemes for providing livelihood and upliftment of the poor sections of the society.

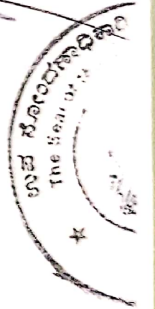

5. The Trustees shall be at liberty to sell, mortgage, purchase, alienate and transfer the Trust properties for the expansion and development of the activities of the Trust.

6. The Trustees shall be authorized to borrow and raise loans from any Nationalised banks or private banks and other financial institutions and also from Government of India and Government of Karnataka against the security of the Trust Properties for building, working men's Hostels, Destitute, Homes, Colleges, Hospitals etc., as herein before mentioned.

7. The Trustees may establish teacher training institute, Computer Institute, Tailoring Training Institutes, Adult Education Centre and Health Family Welfare centers and to eradicate illiteracy among the Rural masses and legal awareness programmes and also slum dwellers by giving priority to socially and economically weaker and also women and children in particulars.

8. To establish and maintain orphanages, Destitute home, Cottages, creches, Old age homes, Hospitals and provide medical facilities to rural and urban slum areas and encourage family planning.
